# Information for Nominations and Elections – 2022 UPDATED November 12, 2021

Positions to be filled by election at the 2022 Convention are:

## 1. STANDING COMMITTEE

The Standing Committee is a Council of Advice to the Bishop. When there is no Bishop, the Standing Committee is the Ecclesiastical Authority for all proper purposes. The Standing Committee consists of 4 clerical members (who shall be elected for 4-year terms) and 3 lay members (who shall be elected for 3-year terms). The Standing Committee generally meets monthly or at the special call of the President of the Standing Committee or the Bishop. The Standing Committee serves as the Resolutions Committee for Meetings of all Conventions.

#### To be elected:

One clergy person to be elected to a 4-year term One lay person to be elected to a 3-year term

The term of The Reverend Christopher Rodriguez expires at the conclusion of this Convention and he is not eligible for re-election at this Convention. The term of Mrs. Monica Tyedmers, elected to fill the unexpired term of Mr. Sid Glynn, expires at the end of this convention and she is eligible for re-election.

**NOTE:** The President of the Standing committee serves *ex officio* as a member of the Diocesan Board. No other person may serve on the Standing Committee and the Diocesan Board at the same time (Canon VI.2)

#### 2. DIOCESAN BOARD

The Diocesan Board is the Board of Directors of the corporation known as the Diocese of Central Florida, Incorporated. The affairs of the Diocese not falling within the exclusive province of the Bishop shall be managed by the Diocesan Board. Members of the Board shall be elected for 3-year terms. The Diocesan Board generally meets monthly or at the call of the Ecclesiastical Authority. Board members are encouraged to serve on a Commission or Committee of the Diocese which meets at the call of the chair.

#### To be elected:

One clergy persons to be elected to a 3-year term Two lay persons to be elected to a 3-year term

[Deans (clergy) and Presidents (lay) are elected by their respective deaneries and serve a 3-year term on the Diocesan Board]

The terms of The Reverend José Rodriguez and Mr. Paul Lagassey expire at the conclusion of this Convention and they are not eligible for re-election at this Convention. The term of Mrs. Tricia Powell, elected to fill the unexpired term of Mrs. Sue Grosso expires at the conclusion of this Convention and she is eligible for re-election at this Convention. The term of The Very Reverend Lisa Wimmer, elected to fill the unexpired term of The Very Rev. John Kelly expires at this Convention and she is eligible for election at a Deanery Convocation or at this Convention.

The terms of the following people expire at the conclusion of this Convention and they are not eligible for re-election at this Convention or at a Deanery Convocation:

- Ms. Krisita Jackson (President, Central Deanery)
- The Very Reverend J. Garry Edwards (Dean, Southeast Deanery)

## 3. TRUSTEE, UNIVERSITY OF THE SOUTH – updated November 12, 2021

Trustees of the University of the South elect and appoint the Board of Regents, a Chancellor, the Vice Chancellor and a Chaplain. Trustees hold the land in trust for the University, promote church support and student enrollment, and approve or reject plans for growth and development. They meet annually and ratify the work of the Board of Regents.

## To be elected:

One lay person to be elected (3-year term)

The Lay Person elected Trustee at this Convention will begin serving a three-year term July 1, 2022.
